5. Spearhead waste management by reducing, re-using, recycling, recovering and safe disposal of effluents.
6. Adopt principles of green procurement by incorporating appropriate provisions in contracts and procurements.
7. Maintain positive legal compliance to environmental regulations and conform to the requirements of Acutaas Chemicals Sustainability Framework.
8. Take initiatives towards efficient use of natural resources and energy; reduction and prevention of pollution; and promoting waste avoidance and recycling.

14. Toxic waste to be handled with professional guidance and mechanism should be put in place to dispose-off the waste to authorised waste processors.
15. Use of renewable sources of energy wherever possible so as to become more energy efficient and energy independent. Identify the scope of replacing conventional sources of energy with sustainable and renewable sources in operations.
